THINGS MY PROVIDER EXPLAINED TO ME

1. THE NATURE OF THE SERVICE BEING PROVIDED
2. THE TYPES OF MATERIALS AND ADHESIVES BEING USED
3. THE *MOST FREQUENTLY OCCURRING* RISKS OF THE SERVICE:

-BLEPHARITIS: A CHRONIC EYE CONDITION THAT IS DIFFICULT TO TREAT. SYMPTOMS INCLUDE (BUT ARE NOT LIMITED TOO): *EYELID REDNESS, IRRITATION, PUFFY EYES, CONTACT LENS INTOLERANCE, EYELASH RUBBING AGAINST EYEBALL, LOSS OF EYELASHES, DISCHARGE, DRYNESS, ITCHINESS, OR WATERY EYES*

-TRACTION ALOPECIA: *HAIR FOLLICLES CAN BECOME IRREVERSIBLY DAMAGED SO THAT THE HAIR DOES NOT REGROW. SYMPTOMS INCLUDE: A RECEDING HAIRLINE TYPICALLY AROUND THE FOREHEAD, TEMPLES, OR NAPE, SMALL PIMPLES APPEAR ON THE HAIRLINE, REDNESS, ITCHING, AND ULCERS, THE HAIR PARTING WIDENS, PATCHES OF THIN OR BROKEN HAIR IN PLACES WHERE THE HAIR HAS BEEN UNDER STRAIN, PATCHES OF SHINY, AND SCARRED SKIN IN MORE ADVANCED CASE*
